The Chartered Accountants Act, 1949 for regulating the profession of Chartered Accountancy in the Country. - Business economics & Business and commercial knowledge.

The CA foundation course exam going to be held in the month of May and November every year. The CA Foundation exam will depend upon the negative marking for paper 3 and paper 4. CA Foundation exam going to be held on objective and subjective type. There is no negative marking for paper 1 and paper 2 candidates need to score at least 40% and aggregates 50% marks in the overall subjects.

### **Eligibility Conditions**

- A candidate passed / appearing in the Senior Secondary (10+2) Examination or equivalent thereto shall be eligible to appear in the CSEET.
- All Graduates/Post Graduates who were hitherto eligible for registration directly to CS Executive Programme, shall also be required to pass the CSEET to become eligible for registration to CS Executive Programme.

- Business Communication (50 marks)
  - Legal Aptitude and Logical Reasoning (50 marks)
  - Economic and Business Environment (50 marks)
  - Current Affairs, Presentation and Communication Skills (Viva Voce) (50 marks)
- CS Executive Entrance Test of 120 minutes consisting of four parts viz. (i) Business Communication; (ii) Legal Aptitude & Logical Reasoning (iii) Economic and Business

Environment & (iv) Current Affairs; and  
b) Viva Voce of 15 Minutes on "Presentation and Communication Skills"

### **Pattern of the CSEET**

The Institute will conduct CS Executive Entrance Test based on Objective Type / Multiple Choice Questions and viva-voce for testing listening, written communication and oral communication skills. There will be four papers in CS Executive Entrance Test. Each paper will contain Objective Type / Multiple Choice Questions having one or two marks each with four options with one correct answer. The duration of the Test shall be 120 minutes and viva-voce on Presentation and Communication Skills of 15 Minutes.

### **The next step after passing CSEET is Executive Programme**

Once the foundation programme is cleared, the aspirant gets promoted for the executive programme. Though the graduates of all stream except fine art and members of ICWAI or ICAI can directly apply to this programme.

### **Professional Programme**

The candidate, who has completed the executive programme, will then be examined in the professional programme, which comprises 3 modules.

### **Job Prospect For CS**

As a qualified company secretary, you can find good position in the private sector and public sector banks and financial institutions. You can look for openings in stock exchanges, the Department of Company Affairs, Company Secretaries have the added advantage of setting up their own consultancy business after obtaining a certificate of practice. #### **How to Be a CWA (CMA)? First Step is Foundation Course**

After completing 10+2, one can apply for foundation course.

#### **CMA-Foundation Subjects:-**

- Fundamentals of economics and Management
- Fundamentals of Accounting
- Fundamentals of laws and ethics
- Fundamentals of Business mathematics and statistics.

#### **QUALIFYING MARKS FOR CMA**

##### **FOUNDATION:**

A candidate shall be declared to have passed the Foundation Programme examination if he/she obtains a minimum of 40% marks in each subject and 50% marks in aggregate of all the subjects put together.

##### **Intermediate Course**

After graduation or after clearing the foundation course, one can go for intermediate examination. For appearing in intermediate course, it is mandatory to undergo postal or oral tuition. This course has two groups, Group I and Group II.

##### **Final Course**

After clearing the Intermediate Examination, one is qualified for the Final Examination. This course also has two groups, Group I and Group II.

Now, it is mandatory to under go three year training, to be a qualified CMA.

#### **Work Profile of CMA**

A cost and works accountant, establishes budgets and standards, evaluates operational efficiency of an

organization and the effectiveness of production and service management, formulates the profile planning programme, guides managerial decisions, and thus renders valuable assistance to the management. Successful CMA holds important position as that of managing director, finance director, Accountant, Cost Controller and Chief auditor in various sectors.

Cost & Work Accountant (Now called Cost & Management Accountant (CMA) deals with collection, classification, analysis and interpretation of cost related data, to help the top management, in making the right decision at the right time. They look into costing of products and services, planning and implementation of effective cost management systems, inventory control, optimization of costs, associated with various aspects, investment analysis, project management, internal audit of business transactions, etc.

CMA Foundation Examination is held twice a year in June and December.

## **NDA Entrance Exam**

The entry in NDA is through NDA Entrance Exam, conducted by the Union Public Service

Commission, twice a year, generally in the month of April and September. The entry in NDA is restricted to unmarried males only. One must be in the age group of 16½ to 19 years and must have cleared 10+2 or appearing in the 12th Class examination. One must either be a citizen of India or a subject of Bhutan or Nepal, or a Tibetan refugee, who came over to India before the 1st January, 1962 with the intention of permanent settlement of India. A person of Indian origin, who has migrated from Pakistan, Burma, Sri Lanka and East African Countries of Kenya Uganda, the United Republic of Tanzania, Zambia, Malawi, Zaire and Ethiopia and Vietnam with the intention of permanent settlement in India are also eligible.

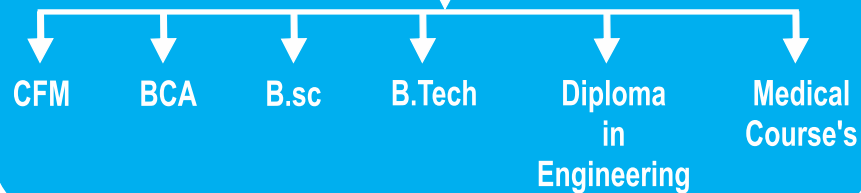
